Member Information Request and Information Use Agreement

Member Information Request

I, _____ a member of Wasco Electric Cooperative, Inc. (the "Cooperative") request to examine the following information:

My purpose for examining this information is:

I understand that the Board of Directors for the Cooperative may deny my request to examine Cooperative records if they determine the request is not directly related to business or affairs of the Cooperative and is contrary to the best interests of the cooperative.

Information Use Agreement

I acknowledge that any information that I examine or copy pursuant to my information request belongs to the Cooperative and is not public information. In exchange for the Cooperative's agreement for my use the information that I have requested to examine, I agree to the following terms and conditions concerning the use, disclosure, or dissemination of such information.

The term of this Agreement commences upon the date that I execute this Agreement as set forth below and terminates upon my return of all Cooperative information that I have received. I agree upon the return of any such information, I will destroy or provide to the Cooperative any copies, summaries, or other work product that I or others have created based on the information that I received from the Cooperative. If I retain or distribute any such information after the termination of this Agreement, the remedies available to the Cooperative as set forth in this Agreement shall survive the termination of this Agreement and shall remain effective and available to the Cooperative to prevent any misuse or unauthorized use of such information.

I acknowledge that the Cooperative has released such information under the condition that I will use the information only for the express purposes that I have specified above.

I recognized that such information may contain confidential materials and records concerning the Cooperative's members and the Cooperative's business or affairs. I agree that such information is confidential and, to protect the interests of the Cooperative members and the Cooperative, I agree to hold such information confidential and not disclosed to such information to any third parties or other persons unless: i) I receive prior written authorization from the Board of Directors for the Cooperative, and ii) I restrict the use of such information for only those purposes specified above.

I acknowledge and agree that any unauthorized use, disclosure or dissemination of the information and materials that I have received pursuant to this information request may result in irreparable harm or serious injury to the Cooperative or its members and monetary compensation may not be a sufficient remedy for such unauthorized use, disclosure or dissemination of such information.

I agree that the Cooperative will have the right, without limitation, to seek and obtain injunctive relief, specific performance and other equitable relief, without proof of monetary damages, to enforce the obligations imposed on me pursuant to this agreement, in addition to any other rights or remedies that the Cooperative may have.

In addition to all other remedies available to the Cooperative, I agree to pay and reimburse the Cooperative for all costs and expenses (including without limitation reasonable attorneys' fees and expenses, before trial, at trial and on appeal) that the Cooperative incurs in connection with any action or proceeding to enforce these provisions or to recover damages or other relief on account of any alleged breach of my obligations under this agreement.
